

International Student Programs request to temporarily suspend enrolment form



This form is to be used by Overseas students, and Education Queensland International (EQI), International Student Programs (ISP) staff for initiating a temporary suspension of a student's enrolment in accordance with the relevant policy and procedures, and their Enrolment Agreement. Please note that suspending enrolments can affect student visa conditions and we advise Overseas students contact the Department of Home Affairs to seek advice about any potential impacts on this visa, including the need to obtain a new visa.

Privacy statement

EQI is collecting the information on this form to assess a request for approval to temporarily suspend enrolment. Your personal information will only be dealt with in accordance with the relevant Australian privacy laws. The information collected on this form will be provided to the student's parents, homestay provider (where applicable), school and EQI. The information will be recorded, used and disclosed for the purposes of the Director, International Student Programs (ISP), on behalf of EQI considering and approving or declining to approve a request. This information may be used for behaviour management and to cancel a student's enrolment if false or misleading information is provided, or failure to provide relevant information. Personal information may otherwise be used or disclosed where authorised or required by law. Suspensions will only be approved in compassionate or compelling circumstances (for example, illness where a medical certificate states that the student is unable to attend class), or for misbehaviour. Declining to approve a request, may have an impact on the student's attendance requirements, which may affect their visa. If approved, a Travel and activities request form may need to be completed.
