The use of information associated with criminal history checks is covered by the confidentiality provisions of the section 278 of the <u>Public Sector Act 2022</u>, <u>Information Privacy Act 2009</u> and <u>Information Privacy Guidelines</u> and by submitting this form the agency is authorised to:

- Seek information from the Queensland Police Service, and other Police Services in Australia for an Australian National Criminal History Check, for any details of any convictions (including any charges, convictions (including findings of guilt or pleas of guilty, whether or not a conviction was recorded) and certain investigative information, or
- Seek additional information from courts, police and prosecuting authorities.

An applicant can withdraw their consent to screening at any time before a decision is made about a person's suitability. If consent is withdrawn employment cannot be offered.

Under section 73 of the <u>Public Sector Act 2022</u> employees are required to give notice of any charge or conviction for an indictable offence. The Act also requires prosecuting authorities to notify the department's chief executive if a public sector employee is charged with a relevant offence. For an employee engaged in child related duties, this notification also includes other relevant police information.
